#### MEETING NOTES

#### Queen City Clean Waters (QCCW) – Mission & Vision

- Vision Cleaner waters and a more resilient Buffalo, NY
- Stakeholder Advisory Committee (SAC) will be specific to certain projects.
- QCCW is the umbrella and model to engage the community during and after construction.
  - Previously was known as the Long-Term Control Plan (LTCP), which focused on wet weather sewage prevention for going into waterways.
- Goals: Improve waterways and the community
  - The City of Buffalo has mandated that \$1 Billion is spent on 50+ sites/projects within the city, including the Bird Island treatment facility.
  - It is important to reduce pollutants and upgrade the treatment facility.
  - WWTP discharges to Emerald Shiners with endangered species.
  - Compliance needs to be met with regulations at the state and federal levels.
  - o Meet with elected officials and partner with local organizations.
  - 0
  - Who will be involved?
    - Target outreach for specific projects, focusing on environmental groups as partners.
    - City agencies are important as the facilities will be in City parks (separate from the Buffalo Sewer Authority)

#### Stakeholder Advisory Committee (SAC) – Purpose

- Water equity and social impact practices
- Vital bridge for the community and their voices to minimize construction disturbances.
- Stakeholders are to be engage with the community and are to help guide the PMT on the engagement process.
- Stakeholders to attend and actively participate in the monthly (virtual/recorded) meetings. Roll calls will be taken, and meeting minutes will be distributed throughout the duration of SAC involvement, unless terminated by any of the parties.

#### • Community Participation Plan (CPP)

- CPP is a form of the Community Benefits Program (CBP) that will be used to make commitments to the Buffalo community.
- A relationship within the residential areas is desired, specifically pertaining to the construction equipment and traffic cones, detours, and protocols for contractors.
- Best Practices
  - Engage with the community partners early, regularly, and consistently.
- D/M/WBE
  - A suggestion was made about putting together a landscape analysis of the existing D/M/WBEs in the area.
  - Want more companies who qualify for D/M/WBE to be certified.
  - What are some of the reasons behind companies not qualifying for D/M/WBE?





Construction Impacts and Mitigation Measures

- During construction, residents can expect to see equipment and traffic cones off to one side of the road
- Temporary disruptions, such as noise and dust, will be minimized as much as possible.
- Sewage odors will NOT be present in homes but may be present outside.



# **Construction Impacts and Mitigation Measures**

- Residents may experience temporary sewer and water service interruptions for a few hours, with advance notifications provided.
- These interruptions will not last days. We will address concerns about explosives, drilling, dust, and air pollution, and manage environmental hazards like asbestos and PCB-laden soils per best practices.



Buffalo Sewer is working diligently to improve the City's existing sewer infrastructure in a costeffective manner. This project will extend the sewer to homes that currently do not have a large enough sewer in front of their house. New storm sewer will be also added and any lead water services will be replaced.

### What is included in this project?

#### For Houses 264 to 276 N. Ogden Street:

- New sanitary sewer
- New storm sewer
- House / building lateral replacements
- Replacement of any lead water services
- New sidewalk, driveway aprons, and pavement

#### When will construction begin?

- Construction is scheduled to start in October 2024 and finish by the end of Fall 2024.
- Notices will be hand-delivered to residents one week before construction starts.

# Construction Impacts and Mitigation Measures

- New traffic patterns will be in place during construction, including:
  - Partial or full road closures
  - Sidewalk closures
  - Limited street parking
  - Possible detours (for vehicles, cyclists and pedestrians)/ relocated bus stop
  - Rodent control plans
  - Fencing and site visibility


