Water Access Barriers & Issues

Urban farms provide numerous community, health, and environmental benefits, including reducing storm water run-off. Water is essential for urban food production and is often a limiting factor for urban farms and gardens. Constructing wells is costly for urban farmers and can cost thousands of dollars. Access to water via fire hydrants requires a permit, equipment and installation, and is currently limited to only non-profit community gardens with requirements to utilize an expensive back-flow meter. With temperatures on the rise as a result of climate change, water issues will only increase making it difficult for urban producers to culturate and sustain their farms successfully.]

Recommendations

 Establish reasonable rates for City Water, through fire hydrant or other means of access for nonprofit and for-profit urban farms. As urban farms and community gardens provide many environmental benefits, including storm-water retention mentioned by the City of Buffalo Sewer Authority in Raincheck 2.0, access to lower, more reasonable water rates should be considered.

2. Reduce the cost of water-line installation. The cost of installing a water line and connecting it to the municipal supply is a huge financial and logistics barrier. This also poses a planning and zoning issue as well as there is no designation for urban farms and community gardens so they are zoned as vacant residential land. San Francisco currently offers a grant designed to help urban agriculture projects and community gardens better manage their itrigation water use. The program offers a one-time waiver up to \$12,000 for the installation of a new dedicated irrigation water service and meter for eligible projects that will be maintained for a minimum 10-year span. One way to credit urban farms for water usage could be based on the square footage of previous surface on the farm.

3. Offer a water credit to good neighbors who allow urban growers and community gardeners access to their outside water spigots. The Water Bureau in the City of Rochester will apply a credit of 7,000 gallons (annually) to the water account of a neighbor who supplies water to a community garden.




