- Roosevelt Park OLS – in preliminary design phase, the Program team is developing the engagement plan and has held preliminary discussions with the adjacent Charter School of Inquiry. (Formerly the Edison Martha Project)
- Sidney Lark OLS – design is in the final stages of completion; stakeholder engagement will be critical for this project given the proximity to Humboldt Parkway and the Scajaquada Expressway
- Hennepin Park – Is the first of several of BSA's Green Infrastructure projects, funded through Rain Check 2.0, mostly at intersections throughout the East Side, Buffalo Public Schools, Buffalo Municipal Housing and 3 Parks on the East Side. These projects will capture storm water and address drainage issues to prevent flooding in urban areas.
