Item #1 A Junior Sanitary Engineer who had been assigned to provide construction observation and project management services for this contract has resigned and CHA is the Engineer of Record for this project and has therefore been deemed most qualified to perform this work.

Item #1 Time Extension of 226 days for final restoration

REASON FOR CHANGE OR EXTRA WORK:

Item #1 Removal and disposal of unanticipated material, winter shutdown, utility work due to discrepancy between record drawings and field conditions.

COST OF CHANGE OR EXTRA WORK:

Item #1 N/A

WHEREAS: On October 20, 2021, the Board of the Buffalo Sewer Authority authorized the General Manager to enter into and execute a contract with STC Construction, Inc., for the Broadway at Oak Real Time Control project at a cost not to exceed \$3,378,000.00; and

WHEREAS: On June 22, 2022, the Board of the Buffalo Sewer Authority authorized a \$177,287.80 Change Order to this contract for removal and disposal of radioactive material; and

WHEREAS: The Principal Sanitary Engineer and staff and CHA have reviewed a request for a time extension only Change Order No. 2 to Contract No. 82000039 as detailed above and recommend approval.

CONTRACT SUPPLEMENT CONDITIONS:

1. The contract completion date established in the original contract or as modified by previous contract supplements is hereby changed by 226 calendar days to set a new final completion date of July 1, 2023.
2. Any additional work to be performed under this contract supplement shall be carried out in compliance with the specifications included in the preceding description of changes involved with the supplemental contract drawings designated none and under the provisions of the original contract, including compliance with applicable equipment specifications, general specifications, and project specifications for the same type of work.
3. This contract supplement unless otherwise provided herein does not relieve the Contractor from strict compliance with the guarantee provisions of the original contract, particularly those pertaining to performance and operation of equipment.
4. The Contractor expressly agrees that he will place under coverage of his performance and payment bonds and Contractor's Insurance all work covered by this contract supplement. The Contractor will furnish to the Owner evidence of increased coverage of his performance and payment bonds for the accrued value of all contract supplements that exceeds the original contract price by twenty percent (20%).
5.
