**INVITATION TO BID**

Sealed bids will be received, opened and publicly read aloud by the Buffalo Sewer Authority at the TYLin Buffalo office, 77 Broadway Street, Suite 208, Buffalo, New York, 14203 at **11:00 am, local time on Thursday, March 28, 2024**, for the **"Bird Island Wastewater Treatment Facility Primary Renovation Project."** Bidders shall deliver their proposals to the **Bird Island Wastewater Treatment Facility**. The work is organized as two contracts, Contract A and Contract B. There is one set of bid documents for both contracts. The Bidder may bid on: (1) Contract A, (2) Contract B, and/or (3) Contract C (Combined Bid for Contracts A+B). The Bidder understands that the Buffalo Sewer Authority can select the Combined Bid, with the expectation that the combined bid cost is less than that Bidder's individual bids for Contract A plus Contract B.

The following three meetings will occur:

- **Meeting #1:** The **mandatory** Pre-bid Meeting to discuss the project scope and answer initial questions. The meeting be held on Tuesday, February 20, 2024, at 11:00 am, local time via MS Teams. - **Meeting #2:** A **mandatory** pre-bid meeting to discuss the conditions to meeting NYSEFC funding for the project. Bidders should ensure that the appropriate people from their team attend.
