WHEREAS: The Buffalo Sewer Authority is a public benefit corporation created pursuant to the laws of New York. The State has delegated to the Buffalo Sewer Authority the responsibility, among other tasks, for providing an effective means of relieving the Niagara River and other tributary streams from pollution by sewage and waste. The Buffalo Sewer Authority has accepted its responsibility and continues to fulfill that responsibility in numerous ways to the benefit and betterment of the residents it serves.

WHEREAS: The Buffalo Sewer Authority has jurisdiction, control, possession and supervision of the existing sewer system to exercise all the rights and privileges necessary for carrying such power into execution. Said purposes are public purposes because the Buffalo Sewer Authority performs an essential governmental function.

WHEREAS: As it evolves, the Buffalo Sewer Authority constantly seeks and engages in projects and initiatives that improve the water quality of the residents it serves. Toward that end, the Buffalo Sewer Authority, working in tandem with Buffalo Water, requests authorization to create a not-for-profit corporation for the charitable purpose of aiding persons living in Buffalo, New York area who are in need of assistance with water and sewer needs. Such charitable purposes also include outreach opportunities to educate and support residents in ways that enhance the public benefit that the Buffalo Sewer Authority is charged with providing. No funding is required from the Buffalo Sewer Authority.

WHEREAS: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Certificate of Incorporation.
